It was informed to the Council that an amount of Rs. 0.9 Crore has been sanctioned for the equity initiatives and the UT of DNH has received the first installment of Rs.0.45 Crore. The first installment is in the process of being transferred to the RUSA account of Dr. APJ Abdul Kalam Govt. College.

Shri Seju P Kuruvilla, Director (Education) / State Project Director (RUSA) sought the approval of the Chair to take up the items on the agenda for the approval of the Mission Authority. With the approval of the Chair, he requested the Nodal Officer for RUSA, Dr. Sony Amrendra to present the agenda items.

The following agenda was transacted by the Council.

## To approve the plans purposed under the head of equity initiatives. 1.

The State Nodal Officer (RUSA) informed to the Council that equity initiative is one of the components and will benefit the girls students (54% of total students), the students from SC / ST / OBC / Economically Weaker Section.

The below mentioned six (06) projects under equity initiatives, have been proposed by the Dr. APJ Abudul Kalam Government College.

- Setting up of English Language Lab. (a)
- GYM for girl students. (b)

- (c) Upgradation of girls washrooms.
- (d) Setting up of Computer Lab for girls.
- (e) Remedial Classes for weak students / slow learners.
- (f) Career counseling / placement workshops.

The fund of Rs. 0.45 Crore has been received and 25% of the allocated fund is to be spent by the end of May, 2016.

The overall perspective and benefits of the proposed six (06) projects under equity initiatives were discussed by the Council. After detailed deliberations, the Council was of the opinion that the below mentioned three projects should be taken up in Dr. APJ Abdul Kalam Government College.

- (a) Setting up of English Language Lab.
- (b) GYM for girl students.
- (c) Upgradation of girls washrooms.

All the members unanimously consented the above three proposals / projects under equity initiatives to be taken up in Dr. APJ Abdul Kalam Government College and recommended the same for the approval of the Hon'ble Administrator / Chairman, SHEC.

The Hon'ble Administrator / Chairman, SHEC, accepted the proposals and conveyed the approval as recommended by all the members of the Council.

The Council decided that the other three (03) initiatives i.e (a) Setting up of Computer Lab for girls, (b) Remedial classes for weaker students / slow learners and (c) Career counseling / placement workshops could be taken up on the release of second installment of funds for RUSA.
